It was clarified that the Placement Officer attends the Executive Council Meetings in an advisorary role.

BY-LAWS AMENDMENT: It was moved, seconded, and passed that By-Law 6 be amended to read: A \$6.00 advanced registration fee or \$8.00 late or on site registration fee for the annual meeting shall be charged in addition to the \$2.00 annual dues for members. The registration fee for non-members shall be \$10.00. The host institution is authorized to spend up to \$800.00, excluding postage which will be paid by MACTLAC.

NOMINATING COMMITTEE: President Bosch appointed Harry Neumiller as Chairman of the Nominating Committee. Only a President-Elect was needed for this year. States needing to caucus and select new representatives are Illinois and Michigan.
