## Executive Council Meeting, Friday, October 12, 11:00 a.m.

#### Order of business:

- 1. President Danforth appointed R. Bayer as chairman of the nominating committee, consisting of the state representatives, to draw up a slate of candidates for the offices of president-elect and secretary-treasurer.
- 2. Arild Miller was unable to attend the meeting and his report of the Teacher Placement was presented. A copy of the report is on file.
- 3. It was moved and seconded that we accept the invitation to meet at Lake Forrest College in 1964. Motion carried.
  - 4. The dates for the 1963 meeting at Wabash College were set for Oct. 18-19.
- 5. W. Oelke presented a report on the Physical Chemistry Laboratory Manual. Plans are progressing toward the letting of a contract with the D. VanNostrand Publishing Company.
- 6. It was moved and seconded that we accept seven active memberships. These applications have been recieved since the last meeting. Motion carried.

#### Order of business:

- 1. The minutes of the executive council meeting of Friday, October 12 were read for the information of the members.
- 2. R. Bayer presented the following slate of nominees:

  It was voted that a unanimous ballot be cast for these candidates.

5. The following motion presented by Quentin Peterson, Wabash College:
"The secretary of MACTLAC be directed to compose a letter to the chairman of
the board of the American Chemical Society expressing the concern of the members
of MACTLAC with the new price schedule for Chemical Abstracts. The new price
schedule will necessarily remove the journal from the libraries of a number of
less wealthy colleges, thus seriously affecting, in the judgment of the ACS's
own committee on Professional Training, the ability of these institutions to
train their chemistry students adequately. I would further suggest in this
letter that, as at least a temporary measure, the ACS itself accept responsibility
for quick relief from this problem and thus avoid the breaking of invaluable

runs of CA and the setting of precedents of non-subscription to CA. Motion carried.

- 6. Motion made, seconded and carried that a copy of the letter over the MACTLAC members concern about the rising costs of CA be sent to each member.
- 7. A request was made as a motion to ask Dr. Harry Lewis to make a further survey of the research activities of the MACTLAC schools. Motion carried.
- 8. E. Wolthuis expressed the thanks of MACTLAC to Bill Deskin for his three years of service as Secretary-Treasurer.
- 9.Lewis Smith presented a motion of appreciation by MACTLAC be extended to Alma College and to Howard Potter for the successful meeting. Motion carried.
- 10. Motion was carried to thank Ed Haenisch for facing the lions and the excellent presentation of the "New Minimum Standards for ACS Approval".
